For cancellation beyond this 30 day period for whatever reason, you require an appropriate travel insurance policy with curtailment cover.
- If, once registered and subject to availability, you want to change to an alternative Kilimanjaro Challenge date, a £100 amendment fee will apply and will be due before the change is confirmed, plus any difference in cost of the new challenge.
- Your travel arrangements are fully protected under our ATOL licence number 6296.
- This challenge is strenuous and you need to be healthy, fit and well trained. You must complete the medical questionnaire that will be sent to you and keep us advised of any medical condition that develops prior to departure that could endanger you on the challenge. A doctor's certificate may be required.
- If you are **'self-funding'** you are personally responsible for funding the full cost of your place on the challenge, and your final balance is due 10 weeks prior to departure. Cancellation charges will apply if you choose to cancel your place on the event.
- If you have chosen the **'minimum sponsorship'** option for MAG you commit to raise a minimum amount payable in 2 instalments; at least 80% 10 weeks prior to departure and any balance within 2 weeks of returning. Both instalments will be payable directly to MAG. If you are unable to meet the minimum sponsorship target you are liable to forfeit your place.
- If you have chosen the **'mixed funding'** option you agree to personally pay a further £650 to Action Challenge due 10 weeks prior to departure and commit to raise a minimum sponsorship amount for MAG payable in 2 instalments; at least 80% 10 weeks prior to departure and any balance within 2 weeks of returning (both instalments will be payable directly to MAG). If you are unable to meet the minimum sponsorship target you are liable to forfeit your place.
