I have read and fully understand and agree to abide by the terms and conditions of entry as set out in respect of this event; a full set of terms and conditions is available from the Kilimanjaro Challenge website. I understand that failure to comply with these terms and conditions could result in the forfeit of my place and registration fee, a cancellation fee, or suspension from, this challenge event. A summary of the main terms and conditions of booking effective from 5th April 2011 is detailed below.

- The registration fee is only refundable if your completed medical questionnaire precludes your participation on the event **and** has been returned to Action Challenge within 30 days of your initial registration, **OR** if the challenge event has to be cancelled by Action Challenge. For cancellation beyond this 30 day period for whatever reason, you require an appropriate travel insurance policy with curtailment cover.
- Action Challenge reserves the right to cancel the challenge event if the anticipated number of confirmed participant numbers does not reach at least 15 persons at a point in time not less than 16 weeks prior to the scheduled departure date, and refund all monies paid by you to Action Challenge, or to transfer you to an alternative departure date that is acceptable to you.
- If, once registered and subject to availability, you want to change to an alternative Kilimanjaro Challenge date, a £100 amendment fee will apply and will be due before the change is confirmed, plus any difference in cost of the new challenge if applicable.
- Your travel arrangements are fully protected under our ATOL licence number 6296.
- This challenge is strenuous and you need to be healthy, fit and well trained. You must complete the medical questionnaire that will be sent to you and keep us advised of any medical condition that develops prior to departure that could endanger you on the challenge. A doctor's certificate may be required.
- If you are 'self-funding' you are personally responsible for funding the full cost of your place on the challenge, and your final balance is due 10 weeks prior to departure. Cancellation charges will apply if you choose to cancel your place on the event.
- If you have chosen the 'minimum sponsorship' option for MAG you commit to raise a minimum amount payable in 2 instalments; at least 80% 10 weeks prior to departure and any balance 2 weeks prior to departure. Both instalments will be payable directly to MAG. If you are unable to meet the minimum sponsorship target you are liable to forfeit your place and registration fee.
- If you have chosen the 'mixed funding' option you agree to personally pay a further sum (depending on the challenge) to Action Challenge due 10 weeks prior to departure and commit to raise a minimum sponsorship amount for MAG payable in 2 instalments; at least 80% 10 weeks prior to departure and any balance 2 weeks prior to departure (both instalments will be payable directly to the charity). If you are unable to meet the minimum sponsorship target you are liable to forfeit your place and registration fee.
- Action Challenge will absorb 'Fuel Surcharges' imposed by the airlines operating the flights for the challenge event up to a level equivalent to 5% of the full 'self funding' price of the Kilimanjaro trip that you have booked (excluding any extensions). Any remaining fuel surcharge balances based on this calculation will be invoiced to you, regardless of which funding option you have chosen, and will be due for payment 10 weeks prior to departure, by you to Action Challenge.

- Action Challenge reserves the right to pass on to you, regardless of which funding option you have chosen, the cost associated with any new taxes that are imposed after 1st Jan 2011 which directly impact the cost of your trip, or increases in existing taxes after 1st January 2011, and will be invoiced to you, with payment due 10 weeks prior to departure by you to Action Challenge.
- If any payments that are due from you are not received by the stipulated date, a late payment charge of 5% will be applied, and Action Challenge reserves the right to cancel your place if payment is not received, in which case you will forfeit your registration fee and any additional deposit monies that you have paid to Acton Challenge.
- The challenge itinerary is complicated and may be subject to change. Changes made by you are likely to incur a surcharge. If we have to cancel the challenge we will provide a prompt refund of all monies that have been paid by you.
- You must have appropriate personal travel insurance for this challenge, and we will request details of your policy before departure. Your travel insurance should also cover cancellation by you for circumstances beyond your control.
